THE MIAMI-DADE SHERIFFS OFFICE ORGANIZED RETAIL CRIMES SQUAD ALONG WITH WALMART GLOBAL INVESTIGATIONS HAVE BEEN INVESTIGATING THE FRAUDULENT USE OF COMPROMISED FLORIDA ELECTRONIC BENEFIT TRANSFER (EBT) ACCOUNTS AND NATIONS BENEFIT ACCOUNTS. DURING THIS INVESTIGATION SEVERAL SUBJECTS HAVE BEEN IDENTIFIED TO BE TARGETING SAMS CLUB AND WALMART STORES ACROSS SOUTH FLORIDA IN ORDER TO PURCHASE LARGE AMOUNTS OF PERISHABLE ITEMS.

ON TODAYS DATE, SEPTEMBER 21, 2026, THE MIAMI-DADE SHERIFFS OFFICE AND WALMART GLOBAL INVESTIGATIONS WERE CONDUCTING SURVEILLANCE AT THE SAMS CLUB LOCATED AT 8425 NW 13 TERRACE DORAL, FL. 33126, WHEN DEFENDANTS ROMARIO STEWART AND MYRTHLAND INCE ENTERED THE STORE. DEFENDANT STEWART WAS RECOGNIZED FROM PREVIOUS FRAUDULENT TRANSACTIONS. DEFENDANT STEWART AND DEFENDANT INCE PROCEEDED TO SELECT (20) TIDE LIQUID DETERGENTS EACH VALUED AT \$24.98, (18) CAF BUSTELO VALUED AT \$20.38, (70) SPAM CLASSIC CANS VALUED AT \$25.56, AND (1) MEMBERS MARK CASHEWS VALUED AT \$13.98 FOR A GRAND TOTAL OF \$2,704.59. DEFENDANTS STEWART AND INCE THEN PROCEEDED TO A SELF-CHECKOUT REGISTER. THEY SCANNED ALL THE LISTED ITEMS AND PROCEEDED TO PAY FOR THE ITEMS WITH 10 DIFFERENT COMPROMISED NATIONS BENEFIT VICTIMS PERSONALLY IDENTIFIABLE INFORMATION (PII) ACCOUNTS. THE INCIDENT WAS CAPTURED ON SURVEILLANCE VIDEO. ONCE DEFENDANT STEWART AND INCE EXITED THE STORE THEY WERE DETAINED AS THEY ENTERED THE ROADWAY. WALMART GLOBAL INVESTIGATION INVESTIGATOR TRENT PEEBLES WAS ABLE TO IMMEDIATELY IDENTIFY THAT 10 DIFFERENT NATIONS BENEFIT CARDS WERE USED. SEARCH INCIDENT TO ARREST OF DEFENDANT INCE REVEALED THAT HE WAS IN POSSESSION OF SIX DIFFERENT DEBIT CARDS THAT WERE RE-ENCODED WITH NATIONS BENEFIT ACCOUNT NUMBERS. DEFENDANT STEWART WAS IN POSSESSION OF FOUR DIFFERENT DEBIT CARDS THAT WERE RE-ENCODED WITH NATIONS BENEFIT ACCOUNT NUMBERS. WHILE DETAINED DEFENDANT STEWART SPONTANEOUSLY STATED THAT THE DEBIT CARDS, HE WAS IN POSSESSION OF WERE PURCHASED AT CVS. DEFENDANT STEWART AND INCE WERE ARRESTED AND TRANSPORTED TO TGK VIA THE MIAMI-DADE SHERIFFS OFFICE MIDWEST STATION. NATIONS BENEFIT PROVIDED THE IDENTITY OF THE COMPROMISED VICTIMS CARD HOLDERS PII.
